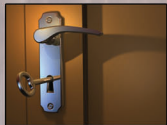

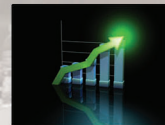

Born in New Haven, CT, on May 22, 1940, Bob graduated from Babson College in 1964. He is Vice Chairman of Babson's Board of Trustees, where he received an honorary Doctor of Laws degree in 1995.
